IN 2016 WE REPAIRED 110 HOMES HELPING OVER 300 PEOPLE WHICH INCLUDED THE ELDERLY, SINGLE MOMS WITH KIDS, AND THE DISABLED. WE MADE HOMES SAFER FOR ELDERLY BY REPAIRING STAIRS AND FLOORS AND INSTALLING ADA BATHROOMS. WE MADE HOMES HEALTHIER FOR FAMILIES BY REPAIRING LEAKING ROOFS AND WINDOWS AND STOPPING MOLD GROWTH. WE HELPED THOSE WITH DISABILITIES MORE EASILY GET AROUND BY INSTALLING RAMPS, DOORS, AND ROLLS IN SHOWERS. MOST OF THIS WORK WAS DONE BY OVER 400 VOLUNTEERS WHO GAINED A BETTER UNDERSTANDING OF THE NEEDS OF THE COMMUNITY AND A FEELING OF CONTRIBUTING IN A MEANINGFUL WAY. THIS INCLUDED OVER 50 HIGH SCHOOL STUDENTS WHO SPENT A WEEK REPAIRING HOMES DURING OUR SUMMER YOUTH CAMP. THIS REPAIR ACTIVITY TAKES THE CRUSHING BURDEN OF EXPENSIVE HOME REPAIRS OFF THE BACK OF THESE FAMILIES SO THAT THEY DON'T HAVE TO CHOOSE BETWEEN FOOD AND MEDICINE OR GETTING THE ROOF FIXED. HOMELESSNESS DECREASES AS THESE HOMEOWNERS CAN NOW STAY IN THEIR HOMES. IN ADDITION, BLIGHT IS REDUCED, PROPERTY VALUES GO UP AND THE NEIGHBORING COMMUNITY IS ENHANCED. AS A RESULT OF THE WORK OF GOOD NEIGHBORS, THESE LOW-INCOME FAMILIES ARE NOW SAFER, HEALTHIER AND MORE HOPEFUL.
