WE HELPED THOSE WITH DISABILITIES MORE EASILY GET AROUND BY INSTALLING RAMPS, DOORS, AND ROLL IN SHOWERS. WHILE PARTICIPATION BY VOLUNTEERS WAS IMPACTED BY THE PANDEMIC, MUCH OF THIS WORK WAS DONE BY OVER 178 VOLUNTEERS WHO GAINED A BETTER UNDERSTANDING OF THE NEEDS OF THE COMMUNITY AND A FEELING OF CONTRIBUTING IN A MEANINGFUL WAY. THE PANDEMIC FORCED CANCELLATION OF OUR ANNUAL YOUTH CAMP BUT WE STILL HAD 20 HIGH SCHOOL STUDENTS HELPING REPAIR HOMES AND LEARNING THE VALUE OF GIVING BACK TO THE COMMUNITY. THIS REPAIR ACTIVITY TAKES THE CRUSHING BURDEN OF EXPENSIVE HOME REPAIRS OFF THE BACKS OF THESE FAMILIES SO THAT THEY DON'T HAVE TO CHOOSE BETWEEN FOOD AND MEDICINE OR GETTING THE ROOF FIXED. HOMELESSNESS DECREASES AS THESE HOMEOWNERS CAN NOW STAY IN THEIR HOMES. IN ADDITION, BLIGHT IS REDUCED, PROPERTY VALUES GO UP AND THE NEIGHBORING COMMUNITY IS ENHANCED. AS A RESULT OF THE WORK OF GOOD NEIGHBORS, THESE LOW-INCOME FAMILIES ARE NOW SAFER, HEALTHIER AND MORE HOPEFUL.
